

Grants are chosen by a committee of five members who are chosen by the Zcash Community Advisory Panel (ZCAP) in an open election. Funding for ZOMG's activities is provided via the Dev Fund specified in ZIP 1014.

4b (Code:) (Expenses \$ 1,191,954. including grants of \$) (Revenue \$) Protocol and Governance: The Zcash protocol and the open network it powers is valuable, privacy-protecting Internet infrastructure; it should be developed and maintained by an open and diverse community of experts and enthusiasts, and it should remain always a tool for financial privacy available to the general public. We will act as stewards of the Zcash protocol, providing leadership and supporting its continued maintenance and improvement.

4c (Code:) (Expenses \$ 211,219. including grants of \$) (Revenue \$) Community: Our goal at ZF is to create tools that help sustain open networks, enabling anyone and everyone to protect their own privacy on their own terms. The essence of privacy itself is being able to choose what is or isn't shared with others. Privacy comprises both autonomy and consent; it is essential to human dignity and the healthy continuation of civil society.
